2. **Release:** The undersigned, being fully aware that participation in any Activities will expose him/her to a serious risk of property damage and or personal injury or death, hereby fully releases and forever discharges Brooke Phillips; Owner of Willamette Sport Horses, LLC; in addition to owners of Caber Farm, owners agents and employees and Owners heirs, personal representative, successors and assigns (collectively released parties), from all liability for any and all property damage, personal injuries, death and other claims arising from the undersigned's participation in or observance of the Activities at the property or any acts or omissions of the Released Parties, including those that are known or unknown, foreseen or unforeseen, future or contingent.
